Meeting Business

Meeting Called to Order: Joe called the meeting to order, 5:38pm

Minutes of February Meeting: Al motioned to approve the minutes; Steve seconded. All in favor. None opposed.

1. Treasurer Update:

- 4. Costs Associated with Online Payments Online credit card processing via a Website have been put on hold until we have another fundraiser.
- 5. Review of Dues Payments Have 4 members still outstanding and missing Manasota. Manasota has paid their KI bill but they still need to pay us.
- 6. Directory Payments Still have 3 outstanding bills for the directory payments.

New Business

1. Storybook Street

Anna and Bridget joined from the Early Learning Coalition to talk about the drive thru event. Will focus on children from birth to 7th. Partnering with Kiwanis as well as other arts and culture groups to bring the books to life. April 24th, Orioles stadium in the East Parking Lot from 9 - 12. Themes will be a variety. Families will enter the parking lot and they will be handed book. The car will crawl into the experience. And then they will enter an experience of the book. May have artists and such perform parts from the book. Looking at possibly 20 stations where they would be handed a book and then see an experience and so on. SKKC will have a booth will use the ELC's fish under the sea theme. Will have to develop a backdrop and a scene. Can work in shifts. Each interaction will be about 30 seconds so we won't be able to rest. Welcome to have signage and posters and such. Need 2 adults for each shift. Limiting to 10 people per booth.

Failure to Engage New Members
 A member brought the following topic to the Board.

Member's Observations:

- 1. As I do the weekly newsletter I've noticed that our President is typically the contact for members wishing to be involved in a project.
- 2. Before this Pandemic year, committee chairs not the President have been the point-of-contact for projects.
- 3. At meetings I've noticed that Chairs are not giving reports. I must point out that Chairs do not have to attend Monday meetings in person. They can report by ZOOM and not every Chair needs to report at every meeting. (Project Chairs are listed in the new Directory. We don't lack for Chairs to give reports.)
- 4. At one point I assumed that somehow the Pandemic was a factor, and it may well be.
- 5. For example concession stand staffing has been difficult. People have not been calling the President in the numbers needed. THAT could be Covid related. (I must therefore be concerned for the SK Easter Egg Hunt.)
- 6. Yet, I have visibility to two projects that require ONLY online participation. They also have not been supported by our newest members.
- 7. RE: #6 new members have stepped forward to work on both these projects. Contact was made by phone regarding the new and most important project, but when asked to attend a ZOOM meeting, many did not participate. In fact, some never responded to the invitation and the post meeting eMails. The most established members of the new committee did participate and some progress has been made.
- 8. RE: #6 in the second project, the new member participants were contacted by phone and agreed to participate (although many were busy so there was some expressed uncertainty). The assigned task in this project was scaled back to accommodate busy schedules. Only one of 4 new members completed their assignment to the required complete date. Two established members were asked to pitch in and help. They did and the project is near completion.
- 9. Both these projects required support from established members who were asked, suggesting perhaps that our newest members are finding it difficult to be involved. If so, "Why?"

Questions:

- Are we expecting too much of our newest members? If so, why do some say "yes" when in the end they might have better said "no?" Why do emails go unanswered?
- Have Board members been active in an effort to invite new members to be involved? If so, it is not working.
- What does all this portend for member retention?
- Has our Club's success metric shifted from "impacting the lives of children who need us the most" to "increasing Club membership?" Why must these be mutually exclusive?

The Board should discuss this - I am deeply concerned that our President is "out there" by himself without Board participation, involvement and support.

The Board started a discussion about member participation and expressed frustration that, as a Board, we are stymied with how to engage a majority of the users. Board will go away and think about it.

1. Strategic Plan Review

Member Feedback: I'm glad to see the Strategic Plan is on the agenda. Other organizations I've belonged to would report to the membership at least annually the status of all the objectives on the strategic plan. Status of the short, medium, long term objectives? Which short-term objectives have met the measurable outcomes to be considered complete? Have they been removed and replaced on the strategic plan? Same question for medium-term objectives? Have any objectives been deleted as being no longer valid? Has the Literacy Project been added to the strategic plan? An additional objective, or an objective outside the

strategic plan? If outside the strategic plan, why?
